## DAYCARE TERMS AND CONDITIONS:

To ensure the health and safety of your dog and all other guests, we require that all of our clients agree and comply with the following terms and conditions:

1. I specifically represent to Central Kentucky Pet Resort that I am the legal owner of my dog. In addition, my dog is healthy, my dog meets CKPR's vaccination standards, my dog has not harmed or shown aggression or threatening behavior towards any person(s) or other dog(s) and my dog has not been exposed to any known communicable disease within a 30 day period immediately prior to admission to daycare. I further represent that each time my dog is brought to CKPR, I will be recertifying that my dog is in good health and has not had any communicable illness of any kind for 30 days prior to admission. I further agree to inform CKPR of any changes in my dog's condition and/or behavior prior to any daycare visit.

2. I understand daycare is offered between 8:30 A.M.– 4:30 P.M. Monday through Friday, dogs not picked up by closing time (7:00 P.M.) will be charged \$25.00 for late pickup. Only 20 daycare day package or higher holders will not be charged. However, after 9:00 P.M. of said day my pet will be rolled into boarding and I assume all charges thereafter.

4. I understand that my dog is required to be fully vaccinated (including Distemper, Parvo, Rabies and Bordetella) and I will provide CKPR with proof thereof from my veterinarian. I agree to provide CKPR with annual updates of my dog's vaccination records. I acknowledge that it is my responsibility to ensure that my dog continues to be fully vaccinated and that CKPR reserves the right to remove my dog from the facility if it is not fully vaccinated.

5. I understand that my dog must have flea and tick protection. I further acknowledge that CKPR shall not be held responsible if my dog contracts fleas and ticks while at CKPR because proper flea and tick protection is my responsibility.

6. I understand that the leash-free environment at CKPR provides dogs the opportunity to play in close physical contact, including with their teeth and paws. I acknowledge that no amount of supervision or personalized care by CKPR, its agents or employees, can prevent the possibility of injury or illness to my dog.

7. I understand that any damages caused by my pet(s) holds me liable to pay for damages to CKPR kennels, property, equipment

8. I understand that daycare at CKPR is a cage/kennel-free service. I accept the risks involved and agree that I am solely responsible for any damages that result from injuries caused by my dog while at CKPR. I agree to indemnify and hold harmless CKPR from any and all claims, liabilities, costs and expenses, including court costs and attorney fees, arising out of any harm or injury caused by my dog to other dogs or persons. . I authorize CKPR to do whatever is deemed necessary for the safety, health and well-being of my dog and I agree to assume full financial responsibility for any and all medical expenses incurred. I expressly wave and relinquish any and all claims against CKPR, its employees, agents, and representatives for any injury, illness, or harm to my dog. Under no circumstances will CKPR be liable for consequential damages or damages beyond the replacement value of my dog.

9. I understand CKPR reserves the right to refuse admittance to any dog that displays signs of untreated or potentially contagious conditions, demonstrates aggressive behavior, or who fails our standard health and temperament policies. I further understand and agree that any problems that develop with my dog will be treated as deemed appropriate by the staff of CKPR, in their sole discretion

10. In the event any provision of this agreement is declared by a court of competent jurisdiction to be unenforceable, the remaining provisions shall remain in full force and effect.
